TOWN OF DEERFIELD

LOCAL LAW No. 5

A local law to install two stop signs on North Gage Road as it intersects with Crooked Brook Road and Cameron Hill Road.

The Town Board, of the Town of Deerfield, having duly applied, and been granted all necessary permits under section 136 of the Highway Law of New York State, to erect traffic control devices on a county road,

HEREBY enacts, pursuant to Article 41, Section 1660 of the Vehicle and Traffic Law, of New York State as follows:

Section 1. Two stop signs, conforming with the Manual of Uniform Traffic Control Devices of New York State, shall be erected on North Gage Road as it intersects with Crooked Brook Road and Cameron Hill Road.

Section 2. The Town of Deerfield shall be solely responsible for the installation, and maintenance of said signs.

Section 3. This local law shall take effect immediately upon its filing with the Secretary of State, pursuant to the Municipal Home Rule Law.
