A MESSAGE FROM THE SUPERVISOR


At last, there appears to be a light at the end of the tunnel. We are preparing for a very business season ahead of us, with much needed road work, ditching and shouldering of roads, as well as tackling some much needed stormwater mediation projects. With that being said, we are going to implement some changes to allow the highway department more man hours to accomplish these tasks. Please see the enclosed Curbside trash pickup notice included in this newsletter.

As most of you are aware, a committee was put together to develop solar guidelines and regulations. The Town has adopted a moratorium on solar but had received an application prior to the enactment of the moratorium. What that means is the application legally had to be reviewed by the Planning Board and ultimately the Planning Board issued Clear Path Energy a special use permit

Another very large proposed solar project by a solar developer has appeared. This one is different. The information we have gathered indicates it will encompass in excess of 900 acres and it a 130 mw project. This process is very different in the State of New York would be the approving agency and not the town. We are in the process of contacting our state representative to get us a "seat" at the table so we can voice our opinions.

As a continued update, a reminder that motorized vehicles (4-wheelers and dirt bikes) are not allowed on town property/trails. As you are well aware, there is a local law prohibiting this activity on the trails. If you are caught on the trails with a motorized vehicle, the Town will pursue all legal remedies.

In closing, take time to enjoy the resources the town offers as well as attend a board meeting. Your thoughts and opinions matter to us.



A MESSAGE FROM YOUR HIGHWAY DEPARTMENT



As spring weather slowly gets here, the Highway Department hopes everyone is well and got

through the winter months safely. When everything finally thaws out, we will begin spring clean-up.

As the weather gets warmer, the Highway Department is scheduled to be out on our spring clean-up; this includes picking up leaves from the fall, tree limbs that fell during the winter months, and sweeping up the sand. We also will be repairing plow damage as we come around town. As in past years, spring clean-up material can be piled out at the curb loose; this is the only time we will be picking up material loose at the curb. Throughout the rest of the year for our green waste pick-ups, brush shall be piled separately at the curb to be chipped. All other material shall be put in a reusable container to be dumped in a compactor truck. As we were plowing snow this season, I saw some people still plowing snow across the road. This creates a problem for the traveling public and the plow drivers, as the snow builds up from pushing it across the roadway. Please do not plow snow across the road.

The Highway Department has a busy construction season planned this year. With our construction season so short to get road work done, one rain or windstorm pushes our projects back from completion in that construction year. Some of the projects we are going to be working on are from 2021 that we were unable to complete. We will be starting on these projects right after spring clean-up is complete. Our projects in 2022 will be split between maintenance projects and construction projects. As soon as the town can get cost estimates on the projects, we can fit them into our budget.

Green waste pick-ups this year will be the same as in past years. We will be picking up green waste once a month from May through November. Brush (defined as tree limbs 1" and larger) shall be piled at the curb with butt ends facing in the same direction for ease of pick-up to be chipped. Brush shall be no longer than 10'. Other green waste shall be put in a reusable container for a separate crew to pick up with a compactor. Larger green waste material can be put out for collection in no larger than 50-pound pieces. Please do not put out root balls with your green waste; we won't be able to put the material through the chipper for collection.

We have added three more Saturday collection dates for trash this year starting on April 23 at Trenton Road Firehouse. Other dates are May 21 at Trenton Road Firehouse (after Garage Sale Weekend), July 30 at Trenton Road Firehouse, August 27 at the Highway Garage and October 22 at the Highway Garage. As in past years, town residents can bring trash items to the Highway Garage for disposal during our normal business hours, 8 a.m. to 3:00 p.m. Monday through Thursday. Please call ahead so we can have people here to open the doors and help unload.

We will be switching over our equipment for leaf season as soon as possible. Green waste will be collected from a container at the curb to be dumped in a compactor. Brush shall be piled separate for collection by a different crew to be chipped. Limbs shall be no more than 10' long or small enough to be handled by one person.

IMPORTANT INFORMATION CONCERNING THE TOWN OF DEERFIELD TRASH PROGRAM

Dear Residents,

Due to the amount of labor and time required, the Town will no longer be able to provide curbside trash pick-up. Last year's curbside trash pick up required approximately 1,000-man hours and almost 30 days to complete. Due to reduced manpower, we need this time to complete the very necessary work of road improvement (paving), shoulder and ditch repair, as well to address long standing stormwater mitigation projects that have been causing flooding in various areas of the town.

You are always welcome to bring trash to the Highway Department on Mondays-Thursdays between the hours of 8:00 am-3:00pm. Please call in advance to ensure someone is there to unlock the dumpsters and assist you in unloading you trash. The Highway Department can be reached at 315-826-7014.

In addition to dropping trash off at the Highway Department, we will be holding additional Saturday drop off dates at the Deerfield Trenton Road Firehouse and the Deerfield Highway Department as follows:

NOTE FROM THE TOWN CLERK

With the Tax Collection out of the way, the hope that some normalcy will return to the Clerk's Office.

The Office is continuing its Monday – Thursday office hours. I still ask that you understand that the office is staffed by only by me and may not be covered if I am out of the office for reasons beyond my control.

Much of the services can be handled over the phone, postal mail, or email, saving you the trip up to the Office building. Of course, if you want to enjoy a lovely country drive by all means come on up.

<u>Dog Licenses</u> are annual and cost \$12.00 for a spayed/neutered dog, \$25.00 if not. Please be sure to provide the Rabies Certificate if it is due.

<u>Accessible Tags</u> (formerly Handicap Tags) will be issued providing the resident has the proper medical form, from his/her doctor. Tags are currently good for 5 years and will need to be renewed after that.

As Registrar, Marriage, Death, and Birth certificates can be filed and/or obtained here in our archives. If you are interested in the research of a certificate, you will need to provide the proper identification, competed form, and fee. Please do not expect immediate service as this process does take time.

Marriage License applications are available by appointment, the cost is \$40.00.

<u>Wilderness Park rentals</u> are conducted through this office. Dates can be booked up to 13 months in advance are strictly a first come – first serve basis. All rentals are subjected to a \$100.00 deposit in addition to a rental fee. Resident fee - \$100.00 and non-resident fee is \$175.00. To check open dates – please go to our website, calendars – Wilderness Park.

<u>Town and County Tax Collection</u> in the Clerk's Office has ended as of March 31st 2022. All payments should be directed to the Oneida County Finance Department at 800 Park Ave. Utica NY 13501.

<u>Deerfield Youth Program</u> has ended its Fall – Spring Program and we are looking forward to the 6-week Summer Program. The program will begin Tuesday July 5th 2022, and will run 4 days a week – Monday – Thursday. It is free to town resident families and charges a non-resident fee for children of our sister towns. 


Wilderness Park - 6329 Walker Rd Deerfield

ANIMAL CONTROL

Pet safety tips to keep your family protected

Pets can be valuable members of your family. When you introduce an animal into your home, help keep everyone safe with these helpful animal safety tips:

- Know the breed of dogs and their disposition. Some dogs tend to bond to one person or family member and become defensive around others.
- Do not try to pet an animal while they are eating, sleeping or caring for their young. Also let them see and sniff you first. Teach children this animal safety approach.
- Teach your children not to provoke or tease a strange animal. Half of all attacks to children are considered provoked.

- Do not hug an unfamiliar dog or other animal, especially around the animal's neck.
- Always supervise small children that are near animals.
- If an animal attacks, you may be able to decrease injury by feeding them your jacket, purse, bike or anything else that can serve as a barrier between you and the animal.
- If you're knocked to the ground, curl into a ball with your hands over your ears and lie still until the animal goes away. Teach this animal safety technique to children.
- For the safety of all, animals should be leashed or in a fenced area at all times.

ASSESSOR'S REPORT

<u>Grievance Day</u> - Every year the Town has Grievance Day on the 4th Tuesday of May. This year Grievance Day is scheduled for May 24, 2022. You can be heard from 1-3 and/or from 7-9 P.M. The only assessment that may be reviewed (grieved) is the assessment on the current tentative assessment roll completed by the local Assessor. As a rule, a separate complaint should be filed for each separately assessed parcel.

PLANNING BOARD

Summary January, February, and March 2022 - The planning board is currently reviewing plans for four sub-divisions in the town. Three are located in the northern part of the town. The fourth is located on Trenton Road. It has been named Pine Ridge Estates. The project has been reviewed by the planning board and other agencies that have input. At the March meeting a few minor changes and additions were recommended by the town engineer. We are anticipating a public hearing on this development in a few months. The moratorium on solar facility development is still in effect. A committee comprised of members of the town board, planning board, zoning board of appeals and residents has been working to create zoning to regulate the future construction of solar facilities in Deerfield. Along with Tier 3 solar projects, this proposal will also address Tier 1 and Tier 2 solar systems. A draft is nearing completion and will be sent to the appropriate agencies for review. The remaining planning board meetings for 2022 are April 6th, May 4th, June 8th, July 6th, August 3rd, September 7th, October 5th, November 9th, and December 7th. All meetings are held at the Municipal Building and begin at 6pm.

We welcome your participation at the Town Board meetings which are held on Monday evenings at 6:30 pm at the Town Municipal Building. It is the best way to find out what is going on in your town and to express your thoughts and concerns. For the 2022 year we will be meeting on the following dates:

Be alert for CO poisoning

Carbon monoxide (CO) is a leading cause of accidental poisoning deaths in the U.S. – second only to drug poisoning.

Literally a "silent killer," CO is a highly poisonous, colorless, odorless and tasteless gas. It is produced when propane, wood, heating oil, natural gas or other fuels burn without sufficient oxygen. CO can build up in enclosed areas quickly, exposing victims to harmful or even fatal levels without their realizing it. Children and the elderly are the most likely to get sick from CO exposure, but everyone is vulnerable. People who are sleeping or intoxicated can die from CO poisoning before they notice any symptoms.

Most CO poisoning incidents are due to improper equipment installation, maintenance or use, which means such incidents are almost entirely preventable. Here some possible sources of dangerous CO levels:

- · A vehicle running in an enclosed garage.
- A generator running indoors, or outdoors within 20 feet of a door, window or vent.
- A gas range or oven used for heating.
- Fuel-burning space heating or water heating equipment that is inadequately vented.
- A propane camping stove, charcoal barbecue or kerosene lantern used indoors.
- A fireplace with a blocked chimney or vent pipe.
- Equipment and appliance exhaust vents that become blocked by flooding, ice or snow.
- Smoldering insulation on overheated electrical wires.
 This can send CO through electrical conduits and into buildings.

Signs of CO poisoning

Watch for these common signs of CO poisoning:

- Headaches
- Dizziness

- Weakness
- Nausea and vomiting
- Confusion
- Sleepiness
- Tight chest

When you suspect CO poisoning, take everyone outside into the fresh air. Seek medical attention for the victims immediately.

Responding to an incident involving CO

If a CO incident is reported in a building served by natural gas, notify National Grid or the local gas utility and take these steps:

- Use full SCBA and PPE.
- Evacuate the building.
- Make sure victims get fresh air and immediate medical attention.
- Ventilate the building.
- Shut off the gas at the aboveground service valve before the meter, provided you have been trained to do so.
- Work with National Grid to determine the source of the carbon monoxide and when it is safe for occupants to return.
- Exercise extreme caution. CO is not only highly toxic, but also highly flammable. It will ignite when its concentration is 12 to 74 percent gas-in-air.
- If possible, carry a CO meter. It will help you identify the presence of CO when responding to medical calls and other situations where CO is not immediately suspected.

CO alarms save lives

CO poisoning can be prevented with the installation of CO alarms, which alert people before CO reaches dangerous levels. These devices are required in the hallway outside every separate sleeping area of a home.


