#### SECTION 1: WRITTEN NOTIFICATION REQUIRED

No civil action shall be maintained against the Town of Deerfield. officers, employees or agents, or the its Town of Deerfield Superintendent of Highways, for damages of any kind or injuries of any kind regarding persons or property resulting by reason of any highway, sidewalk, bridge, culvert, highway marking sign or device, or any other property owned, operated or maintained by the Town, or by reason of any other act of the Town, its agents and servants, whether said action is maintained for non-feasance or misfeasance, or for said properties being defective, out of repair, unsafe, written notice of such obstructed unless dangerous or defective, unsafe, dangerous or obstructed condition of such highway, sidewalk, bridge, culvert, highway markings, sign or device, or any other property owned, operated or maintained by the Town, was actually given to the Town Clerk or Town Superintendent of Highways,

and there was a failure or neglect within a reasonable time after the giving of such notice to repair or remove the defect, danger or obstruction complained of; but no such action shall be maintained for damages or injuries to person or property sustained solely in consequence of the existence of snow or ice upon any highway, sidewalk, bridge or culvert, unless written thereof, specifying the particular place, was actually given to the Town Clerk or Town Superintendent of Highways and there was a failure or neglect to cause such snow or ice to be removed, or to make the place otherwise reasonably safe within a reasonable time after the receipt of such notice.

No civil action may be maintained on the basis of a defect, misfeasance or non-feasance unless such written notice is given and a reasonable opportunity has been accorded to the Town to correct any deficiencies.

## SECTION 2: DUTIES OF TOWN CLERK AND HIGHWAY SUPERINTENDENT

The Town Superintendent of Highways shall transmit in writing to the Town Clerk within ten (10) days after the receipt thereof all written notices received by him pursuant to this Local Law and subdivision 2 of Section 65-a of the Town Law. The Town Clerk shall cause all written notices received by him or her pursuant to this Local Law and subdivisions 1 and 2 of section 65-a of the Town Law, to be presented to the Town Board within five (5) days of the receipt thereof or at the next succeeding Town Board meeting, whichever shall be sooner.

#### SECTION 3: APPLICATION

This Local Law shall supersede in its application to the Town of Deerfield subdivisions 1, 2 and 3 of section 65-a of the Town Law.

#### SECTION 4: EFFECTIVE DATE

This Local Law shall take effect immediately upon filing with the Secretary of State.
