## A MESSAGE FROM YOUR HIGHWAY DEPARTMENT



The Highway Department hopes everyone is doing well and has a fun filled summer planned this year. With summer months being so

short the highway department tries to pack a lot of projects in our short construction season, we will be out working on roads and maintenance projects throughout the construction season. We will try not to hold up traffic any longer than necessary for the safety of the public and our road crew. **Please drive safely and give our crew on the road the time to get their job done. Our children are out of school now, please have a watchful eye for them while driving on our roads.**

Several years ago, the town moved to collecting green waste at the curb with a compactor. By collecting green waste this way it saves the Highway Department time and money. This helps keep our town looking neat and orderly and gives us more time in our short summer months to complete other important projects. After several years of collecting green waste in this manor we are still getting green waste piled loose at the curb. **The town will not be picking up loose green waste, after spring cleanup is done**, we will ask you to remove it from the curb. Residents should put out loose material in a reusable container to be left for next month's collection. Brush defined as tree trimmings ½" or larger in diameter should be put out in a separate pile to be collected by a chipper crew. We are also noticing large debris such as tree stumps and large pieces of concrete that cannot be picked up by hand as we will not be out with the loader to collect large heavy material. As a reminder, Residents can always bring their green waste and hard fill materials to the highway garage to dispose of. As I am driving around town, we notice green waste and brush at the curb weeks before the collection starts. Green waste should not be put out more than 48 hours before the Scheduled collection date. The collection always starts and ends in the same place each month and once we have gone by, we will not be coming back until the next green waste date. **PLEASE REMEMBER DO NOT MIX ANIMAL FECES WITH YOUR GREEN WASTE.**

Just to clear up some questions from new residents in town as to the definition of green waste, Grass clippings, small plants, clippings from bushes and tree trimmings under ½ inch, shall be put out in a reusable container that can be dumped into our compactor. Tree trimmings and brush ½ inch and larger shall be put out to the curb piled net with the butt ends facing out for ease of collection, no longer than 8' to be chipped by the highway crew. In the area at the highway garage set aside for green waste

material we are finding scrap lumber piled which is not considered green waste material, this material is considered construction debris for the dumpsters. Please do not put scrap lumber in this area.

Reminder to the town residents trash items can be brought to the highway garage at 6892 State Route 8 Deerfield during our normal work hours, Monday through Thursday 6am to 4:30pm, please call ahead and let us know when you can bring trash so we may have help available to open doors to access the dumpsters and to assist loading trash into them. The town still has one Saturday trash collection date left this year (October 4 at the Highway Garage on State route 8 from 8 AM to 2 PM). As a reminder to all that use the dumpsters at the highway garage, we welcome all town residents to use the sight during our normal work hours, however the town employees come in after a weekend off we find trailer loads of trash dumped in front of the doors marked with **NO DUMPING AFTER HOURS SIGNS** on the doors. We are going to be putting up cameras on our buildings to find out who is doing this. We are also finding trash put in the green waste area, this is not an acceptable place for trash items. Thanks for your cooperation.

### Road Work

The Highway Department is looking at a very busy summer with some large road projects and the normal maintenance work that needs to be done. As we work on our projects the weather affects and delays what we do and the company's we work with for paving projects. We have started some of our Maintenance work for the 2025 season and have started working on some road projects for 2025 construction season. We will continue to work on them until completion, or the season won't allow us to complete the projects until the following season. As the Highway Department projects continue along, please feel free to call **315-826-7014** with any questions. The Highway Department has been short-staffed for some time, please be patient.

*All Green waste throughout the year will be collected from a container at the curb to be dumped in a compactor. Brush shall be piled separately for collection by a different crew to be chipped. Limbs shall be no more than 10' long or small enough to be handled by one person. Small green waste loose at the curb after spring clean-up will not be picked up.*

## FROM THE OFFICE OF BUILDING & CODES

### IMPORTANT REMINDERS FOR THE COMING BUILDING SEASON

**Inspections:** With the building season gearing up, please remember that inspections **MUST** be made at certain phases of your construction. These inspection phases will be provided with your Building Permit.

The Town of Deerfield Rules and Regulations for the Administration and Enforcement of the Building Code makes the OWNER, APPLICANT, OR HIS/HER CONTRACTOR responsible for informing the Code Office when work is ready for inspection and to schedule such inspections. These Regulations do not allow a CERTIFICATE OF OCCUPANCY (CO) OR COMPLIANCE CERTIFICATE (CC) to be issued unless the necessary inspections have occurred. THEREFORE, IF THE INSPECTIONS ON YOUR PERMIT ARE NOT PERFORMED, NO C.O OR C.C. WILL BE ISSUED FOR YOUR PROJECT.

**Swimming Pools:** We are already getting pool applications in for the spring installs. Please note that many residents bought inflatable pools last year. These pools have the same safety rules and regulations as other above/inground pools, so please call us before purchasing any inflatable pools this year. More importantly, local laws regarding fencing and other safety requireA note from the Town Supervisors for swimming pools may be more restrictive than requirements for swimming pools contained in the Uniform Code. If you are considering the purchase of a swimming pool, you should review the Uniform Code provisions which can be obtained at the Building & Codes Office. In addition, you should consult the building inspector on the local laws, ordinances, codes and regulations for any further requirements before purchasing a pool. Along with the permit, you will also need to call us for your final inspection before using your pool. At that time we will process your certificate of compliance and return your deposit for the electrical inspection report.

**Decks:** As a building inspector, I see a lot of decks that aren't built to code — despite the plan review process, the purpose of which is to identify any code issues before construction commences. But field changes are common, so an inspector is likely to find a different deck constructed at the site than what was detailed on the permit.

For many specifications, like those for spans and guardrails, you have to apply general code requirements.

Consequently, a deck contractor may not be aware that certain changes could result in a code violation. Below are five common reasons decks fail inspection.

- 1. No Protection against Decay:** It's a simple issue, usually noted on the plans, but we sometimes find a completed deck built of standard-grade lumber. Or portions of the deck built with standard grade lumber.
- 2. Too Few or Inadequate Fasteners:** We often find insufficient attachment — which includes the use of nonweather-resistant and/or non-structural fasteners attached to the existing structure, which can cause decks to collapse. Fastener specifications aren't usually called out on the construction plans, and inspectors often find undersized nails, or untreated nails that will be nothing but rust in a year or the fastener just shears off do to the weight of the loads imposed.
- 3. Inadequate or Non-approved Structure:** The IRC (Section and Table R502.5 (1)) no longer allows 4x4s or 6x6s to be used as girders (Figure 4). All structural beams and girders must be constructed with multiple 2x4s to 2x12s, with the depth and the number of layers of the members determined by the span and spacing.
- 4. Insufficient Support and Anchoring:** Whether attached to the existing structure or freestanding, all decks are required to be anchored against uplift and braced laterally to prevent racking and to prevent the deck from becoming a projectile in high winds.
- 5. Missing or Noncompliant Guardrails and Handrails:** Many owners don't want a guardrail to affect the view from their deck. They want something not too tall and often ask for benches or planters to act as guards. Note: that handrails are not guardrails, although the terms are often thought of at the same time. Per section R311.5.6, a handrail is required when there are four or more risers in the stair run and when the stair is more than 30 inches above grade or above the floor below, a guard is also required.

## Services provided by the Town Clerk's office:

- Registrar Service
- Marriage licenses, Certified Marriage, Death and Birth Certificates, if the occurrence took place in the Town of Deerfield.
- NYS Parking Permit for the Disabled – Temporary/ Permanent tags
- Dog Licensing
- Wilderness Park Pavilion Rental Application
- Town & County Tax Collector during the first quarter of each year
- The Town of Deerfield no longer issues Hunting or Fishing Permits – Walmart and Bass Pro are the nearest sites to issue them.

## It's the time of year for Solicitors –

The Town of Deerfield has a Local Law on the books – Basically states that all Solicitors advertising, selling of wares or services, must obtain a Peddler Permit from the Town of Deerfield. The town clerk provides the permit in exchange for Information on the company, solicitor, transportation information & contact information, this is to keep track of those who travel through out town for the protection of its residents. Please feel free to ask to see their permit.

Currently "Go Net Speed", "Glorias Ice Cream truck", "ARK Detailing Services" have active Peddler Permits.

## The Real ID Act

If your New York State license or ID **does not** have a star or a flag on it, then you **do not** have a REAL ID-compliant document.

A REAL ID is a federally compliant DMV-issued driver license, learner permit, or non-driver ID that is required to board a domestic flight (within the U.S.) or enter certain federal buildings, unless you have a valid passport.

### Clerk's Note

***Please note that one form of proof of ID is your legal name, which affects many women, as marriage and divorce, changes our names. The DMV will ask you to provide proof of your past name changes. To do so, you must provide a certified marriage license, if you no longer can locate the original you must provide a certified Transcript of Marriage. To do this you must locate the town, city or village where you obtained your marriage license and request a certified transcript. The cost is \$10.00 to search and if available, provide the transcript. This procedure requires payment up front along with the application. Photo ID is required, with completed application. This procedure does take research and time. Please consider this at the time of request.***

## Bring Proof of Your Full, Legal Name

DMV may only print your legal name on a REAL ID or Enhanced document. A nickname, like an abbreviated or alternate version of your legal name, is not allowed. If a nickname, abbreviated name, or confirmation name appears on any of your proof documents, additional proof of full, legal name, or proof of a court-ordered name change, must be shown.

***If your name has changed once or multiple times due to marriage or divorce, for example, proof of each change, such as a marriage certificate or divorce decree, must be provided to show the connection.***

# PLANNING BOARD UPDATE

At the January and February Planning Board meetings members reviewed and edited a draft of a proposed Local Law regarding the regulation of short-term rentals in the town. The ordinance was completed at the March meeting and sent to the Town Board for review and a public hearing. After the public hearing it was approved as a Local Law. Also in March, PathStone Deerfield Apartments began moving forward with plans for a 65-unit apartment building. In addition to the apartments, First Learning will be operating a

daycare center in a portion of the building. It will have the capacity to service approximately 80 children. Al Swierczek, PE, has been retained to represent the town and review all material submitted by SWBR Engineering. Surveying is being done by Jeff Moore. Jim Papaleo, ARCN Development, will contact the Deerfield Fire Department to determine what first responder services they can provide and what services will need to be handled by other fire departments through Mutual Aid. Lura Raymo will coordinate with area Senior

Citizens groups to make them aware of these apartments, which will offer an economical alternative for Seniors wishing to downsize but remain in the area. Additionally, the Chairman of the Board of Directors for the Utica Center of Development/Veterans Outreach Center has been in contact with Jason Sackett of PathStone to emphasize the need for housing for Veterans in the area. Mr. Sackett expressed an interest in working with the Veterans Outreach Center on this project. At the April meeting members discussed information from Niel Rivenburgh, Jefferson County Fire and Emergency Management and William Lipczynski, Chief of the Chaumont Fire Dept., regarding the Battery Energy Storage Systems (BESS) fire that happened in the Town of Lyme in 2023. The Planning Board requested that the Town Board enact a moratorium on the towns current Local Law #1 of 2023 so that it can be updated to address the most current issues regarding BESS. The new DEC Freshwater Wetlands regulations and their potential impacts on Deerfield were also discussed. PathStone Development and SWBR submitted the conceptual plans to begin the site plan review process for the Deerfield Apartments project. Jim Papaleo, ARCN Development, gave a history of the entire proposal dating back to the fall of 2023. Joshua Fraass and Jason Sackett provided information about PathStone Development and their vision for the Deerfield Apartments. Becky Maier, PE and Joe Gibbons from SWBR presented a description of the conceptual plans. Jeannine Garfield, First Learning, spoke about the daycare portion of the project. The group then addressed questions from approximately 30 town residents. The Planning Board scheduled an additional meeting for May 21st to continue reviewing the conceptual plan. The additional meeting addressed stormwater management, concerns regarding the access road and a preliminary list of items that Al Swierczek is concerned about. There was

another question-and-answer session with town residents. In June Joe Betruss, Councilperson 6th District City of Utica, requested early privilege of the floor. Councilperson Betruss had questions regarding the overall development proposed by ARCN. He requested that he be included in any future meetings that pertain to the ARCN development. Becky Maier, SWBR, presented an updated drawing of the storm water detention area at the Deerfield Apartments. She also met with representatives of the Deerfield Fire Dept. An inventory of upgrades to the conceptual plans was given to Ms. Maier to incorporate into the preliminary drawings. Additional fire protection through Mutual Aid was also addressed. Jason Sackett addressed the access road easement agreement. Kiran Kaur, New Hyde Park NY, requested information about the town's subdivision requirements in regard to property located at 7034 Harris Rd. Chad Angus, Beaton Dr., also requested information pertaining to subdividing property with access from Beaton Dr. and possibly Cosby Manor Rd. The Town Board and the Planning Board held a joint workshop meeting on June 18th to review the preliminary plans for site plan application for Deerfield Apartments. Items discussed were a second review of the proposed plans by Al Swierczek, comments from the Deerfield Fire Dept, the draft copy of the access road easement agreement between ARCN and PathStone Development, stormwater detention area and the draft agreement assigning maintenance of the detention area to PathStone Development, a traffic study for the entire ARCN site and a separate study specific to the Deerfield Apartments, impacts on the Whitesboro Central School District and the potential for additional recreational areas. Please visit the Town website to view the information regarding the PathStone Development site plan application.

## DEERFIELD YOUTH PROGRAM

Our 6 Week Summer Park Program will July 7th and will run Monday through Thursday until August 14th. The Program hours will be 8:30 AM (No earlier drop offs) and a strict pickup time of 3 PM (No Later). This Program is not a Daycare or Summer Camp and cannot be used as such. Our program is open to Deerfield Resident Youth at no cost. Schuyler resident youth is a cost share between the resident and the Town of Schuyler. Ultimately the cost for Schuyler residents is \$125.00 per child, (Proof of Schuyler Residency required) all other nonresidents will pay \$250 per child. These fees must be paid in full at the first visit to the program, there is no refunds or proration. We hope to take 3 field trips, as well as some entertainment to be brought in. Our calendar will be lightly filled with arts & crafts, team sports, learning opportunities and water fun days.

Requirements: All Children must have LABELED, refillable water bottle, daily lunch, morning snack, afternoon snack, & closable bag (book bag, duffle bag,) with change of clothes,

bathing suit and Towel. Please check the lost & found frequently.

We do have a limited budget, so field trips will have a minimum charge. Our counselors cannot give out money to children, for goodies, drinks and souvenirs, this is strictly up to the parents and guardians.

We welcome donations, popsicles, goodies, arts and crafts supplies, sports equipment and games. We appreciate it all.

Registration forms, calendars, and field trip information will be available in the first week of the program. All children must be signed in and signed out in front of a Staff Member.

Registration forms will be available at your child's first visit to the program.

Calendars will be available at the park as well as on the Town Website and our Youth Program Facebook Page.

# ANNOUNCEMENT OF DOG ENUMERATION

*Will take place August 1<sup>st</sup> – September 31<sup>st</sup> 2025*

Dog Enumeration.com Services in Collaboration with the Town of Deerfield will be conducting a Dog Enumeration / Census in the Town of Deerfield.

Your response will be required by law, if you currently own an unlicensed dog.

To avoid fines and possible court summons please complete and answer your enumeration once you receive it.

## ANIMAL CONTROL

### Fear of Fireworks & Thunderstorms

The sounds from fireworks, thunderstorms and other loud noises are common sources of fear and anxiety in many dogs. There are several reasons why a dog may develop this type of fear, such as a negative experience around a specific noise, lack of early socialization as a puppy, underlying illness, or because of worsening anxieties as they age due to changing brain chemistry. The signs of fear can range from mild to severe,

including trembling, vocalizing, panting, pacing, drooling, hiding, digging at doors and escape attempts.

When pets get scared, they may try to flee and escape in search of safety. The source of firework noise can confuse our pets, so dogs may frantically try to escape outside. This leads to pets running away from home and putting themselves in danger of injury or getting lost in their most frightened state. Always ensure your dog's ID collar and/or microchip information are current and secure your home and yard as a precaution.

With some advanced planning, you can help your dog feel safe during a stressful time. Set your dog up for success with the following tips:

- **Talk to your veterinarian** about anti-anxiety medications well in advance. If medications are prescribed, trial them first on a day without noise to see how your dog tolerates them.
- **Give prescribed anti-anxiety medications** early enough before the fireworks or thunderstorms start. It is much easier to prevent a fearful reaction than to reverse one.
- **Exercise or play outside earlier in the day.** Plan bathroom breaks and outdoor exercises accordingly to avoid going outside after the fireworks or storm start. If you must go outside, keep them on a leash, even in a fenced-in backyard, as a precaution.
- **Stay home to comfort them.** Many dogs with noise phobias may also have some separation anxiety, so your

absence may make them even more stressed. If this isn't possible, consider a pet sitter they know and trust. Punishment must never be used because it will only increase your dog's distress.

- **Create a safe space.** This should be in a location of the home they are familiar with and have a cozy bed or blankets. Keep them in a room farthest from the noise and with few or no windows to help decrease outside sound. Only use a crate if they are already accustomed to it and consider it a safe spot.
- **Play white noise and music.** Layering two different types of sound can help drown out the noise. Calming classical music may also help reduce stress.
- **Offer long-lasting treats** such as stuffed frozen Kongs, Lickimats, or other food toys.

In some cases, adjunctive therapies, such as pheromones or other nutraceuticals, may be helpful additions. Always seek scientifically supported therapies as recommended by your veterinarian. If your dog's fear, anxiety and stress feel unmanageable during fireworks, thunderstorms, or other loud noises, speak to your veterinarian, or consider a referral to a veterinary behaviorist, as more extensive treatment, including medications and behavior modification, may be needed.

### Protect your pet from heat stroke during summer festivities

Another reason to keep your pets away from the often noisy celebrations of summer is heat. High temperatures put your pet at risk of heat stroke, which can become deadly very quickly. Keep an eye on your pets and act immediately if you see any signs of heatstroke.

NEVER leave your pet in a parked car, even if the day doesn't seem that warm. The temperature outside may be a balmy 72 degrees, but the temperature inside a closed vehicle can rocket to a fatal 116 degrees in less than an hour.

Also remember that hot pavement can be dangerous to unprotected paws; if it's too hot for you to hold your hand to the ground for five seconds, it's not safe for your dog to walk on.

My family and I moved to Deerfield in the fall of 2021. I'm a lover of history, especially as related to Colonial America, The War of Independence, and America's Founding. I look forward to the adventure of discovering the history of Deerfield just as our founding pioneers wrote the story that transformed this wilderness into our home. In Walter D. Edmonds' novel, Drums Along The Mohawk, Deerfield represents the American Dream, the seemingly elusive ideal, a Garden of Eden representing optimism and possibility. Once the patriots of Deerfield defeated the British and achieved Independence, the founding families returned to their settlements, rebuilt their lives, and built our hometown. I hope to continue to help tell the story of Deerfield.

As the United States of America celebrates its 250th Anniversary in coming years and we celebrate 200 years of the Erie Canal, I hope to share stories of Deerfield and how those who lived here contributed to these world changing events. As I began to explore the history of Deerfield, I hoped to uncover stories of those who contributed to the great engineering wonder of the world that is the Erie Canal. One such Deerfield citizen did arrive in Deerfield in the 1830's and purchased 25 acres. Buried in St. Agnes Cemetery in Utica, Patrick Condon is an internationally recognized 19th Century Irish Language Poet who was celebrated by the Irish Cultural Center of the Mohawk Valley. When Mike Hoke of Irish Cultural Center of the Mohawk Valley reached out to The Deerfield Town Offices, I was glad to assist in my own humble way with his research and to learn of this historical figure who escaped the potato famine in his homeland to enrich the heritage of our hometown.
